STALL FEES:

All stalls have to supply a copy of Public Liability in order to trade on the day.

Stall fees are non refundable and must be paid by **the 12th of February 2010**. A tax receipt will be sent when the approved market stall application, signed agreement and payment have been received.

PUBLIC LIABILITY INSURANCE:

ALL stallholders require Public Liability Insurance for any Koorie Night Market event. You can provide proof of your own Public Liability Insurance or make a one-off payment of \$100 to Koorie Night Market which will cover you for 10 events (very reasonable price).

Proof of your own Public Liability Insurance or payment of \$100 for cover through Koorie Night Market Inc is required prior to the event in order to set-up our stall. Please contact us for more information.

TRADING HOURS, SET-UP AND PACK-UP:

Trading Hours for general stallholders are as follows:
5pm to 8pm, Saturday 13th February 2010

Vehicles will only be permitted on site for the purposes of setting up and packing down within the time periods.

Set-up/ Pack-up Schedule

Set-up is from 3pm - 4.30pm and pack-up can commence after the event finishes at 8pm.

These times will be enforced for safety reasons. If for any reason the vendor should require more time to set up or pack down, they must do so using trolleys with their vehicle off site.

ELECTRICITY, WATER & LIGHTING:

NO electricity or water will only be provided at this event as there is a limited supply. **Lighting of your stall may be required** and the sole responsibility of you the stallholder.
